

**State of Arkansas
Scan Line Specification for
Individual, Corporation, Fiduciary, Composite and Pass-through
Estimated Tax Vouchers (1 - 4)**

Effective immediately, the scan line on all estimated vouchers must use the correct font and font size. The scan line must be in the correct location. If the font, font size or placement of scan line is incorrect, estimated vouchers will not be approved for reproduction.

Font: IdAutomationOCRa

Font Size: 9

There must be a half (1/2) inch clearance around the scanline.

Location:

Bottom of page to bottom of scan line – 16 mm or 0.63 inch

Right edge of paper to right edge of scan line – 25 mm or 1 inch

Left edge of paper to left edge of scan line – 53 mm or 2.08661 inches

Scan line is approximately 136-137 mm long.

RIGHT justified

Grid Location:

On a 6 line per inch/10 character per inch grid with the voucher forced to the bottom of the page, the scan line falls on the line between 62 and 63 or at the bottom of line 62, Space 75, right justified

OCR Scan Line Definitions:

1. Specifically this designates the **Tax Type**. (3 characters in length)
 - a. "IIT" for Individual Income Tax
 - b. "CIT" for Corporate or Sub S Corporation Tax
 - c. "FIT" for Fiduciary Income Tax
 - d. "ICT" for Composite Filing Income Tax
 - e. "PET" for Pass-through Income Tax

2. **ID Type** – EIN or SSN. (3 characters in length)

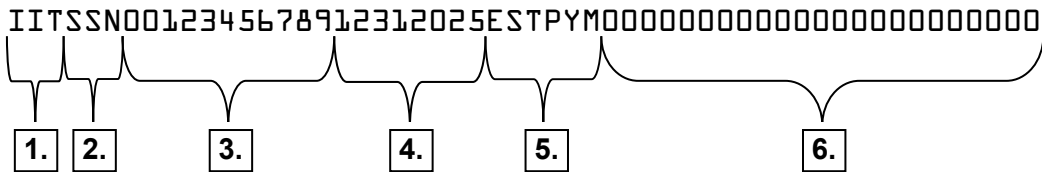
| Tax Type | Corresponding ID Type |
|-----------------|------------------------------|
| IIT | SSN |
| CIT | EIN |
| FIT | EIN |
| ICT | EIN |
| PET | EIN |

3. **EIN or SSN** (must match ID Type in item #2)
Two leading zeros + the SSN/EIN
 - a. Example: 00123456789 (11 characters in length)

4. **Period Ending** - Example: 12312025 (8 characters in length)
This is always the last day of the ending month of the tax year.

5. **Payment Type** (6 characters in length)
 - a. ESTPYM for Estimated Tax Payment (Vouchers 1 - 4).

6. Padded with 23 Zeros
