Greetings from the CA Substitute Forms Program,

We hope everyone's having a great filing season so far. As we prepare for our upcoming 2024 annual tax forms update season, we would like to inform you that we will no longer hold our CTP Symposium.

Our CTP Symposium started in 2015 as a bi-annual, on-site event that featured overviews of our CTP paper products (Substitute, Scannable, 2D Barcode, OCR, and Absolute Position) changes, vendor package review process, and a tour of FTB processing facilities. In 2017 and 2019, security protocols prevented us from conducting live tours of FTB processing facilities, so we switched to a video presentation. Since 2020, we were unable to conduct on-site meetings due to the COVID-19 pandemic. Now that our CTP paper product changes and our vendor review process have stabilized, and we are no longer conducting live tours, the need for our bi-annual on-site CTP Symposium has diminished and therefore will no longer be held. We truly appreciate those who have attended and participated in the past and helped to make the CTP Symposium successful.

RE: **Reminder - Upcoming SWIFT Policy Changes July 11, 2023**

At California Franchise Tax Board, we take the responsibility of transferring our customers' data very seriously and we are committed to providing the best service possible with respect to your electronic file transmission.

This broadcast is regarding an upcoming change to our Secure Web Internet File Transfer (SWIFT) Service that will occur on **July 11, 2023**, that may impact your ability to access files through the SWIFT system.

## **File Retention Changes**

Currently SWIFT's policy is to delete outgoing files that are 90 days old. The policy will change from 90 days to 30 days.

## **FTB Password Criteria Changes**

Currently when a new password is generated, SWIFT customer gets an email with a temporary password of 9 characters which follows FTB's current password criteria. The password length will be changing from 9 characters to 15 characters and the new requirements are below.

SWIFT customers will get an email containing a 15-character temporary password as well as the new password requirements.

New Requirements:

- Contain at least 15 characters.
- Not be the same as your previous 12 passwords.
- Not be similar to your current password.
- Not be similar to your login name.
- Not be similar to your name.
- Not be similar to commonly used passwords.

- Contain at least 4 of these character types:
- Upper alpha
- Lower alpha
- Numeric
- Special character
- Not contain a character pattern like "abcde"
- Not contain more than two sets of repeating characters.

(Note: New customers will be required to adhere to the new password policy and existing customers will be required to adhere to the policy change upon password renewals.)

### **What to look out for**

SWIFT administrators will apply these policy changes during the normal maintenance window on **July 11, 2023, from 5 AM – 7 AM.**

RE: IRS PBA Code Update

As of January 25, 2023, the IRS has updated the principal business activity (PBA) code for an unclassified establishment for Business filers from 999999 to 999000 for the 2022 Tax Year. This update occurred after we finalized our forms/instructions/publications/booklets for the 2022 tax season. This broadcast is to notify vendors of the recent IRS change to allow PBA code 999000 in addition to PBA code 999999, for unclassified establishments, for both PIT/BE taxpayers for the 2022 tax season. Tax returns for both PIT and BE taxpayers with the new code will not be rejected.

We identified the following products that allow for PBA codes: Form 100 Tax Booklet, Form 100W Tax Booklet, Form 100S Tax Booklet, Form 540, Form 540NR, Form 541, Form 565 Tax Booklet, Form 568 Tax Booklet, Form 109 Tax Booklet, form FTB 3554 Tax Booklet, form FTB 3805Z, form FTB 3807, form FTB 3808, form FTB 3809 and Form FTB 3514.

The PBA codes will be updated for the 2023 tax season. The PBA codes will not be revised for the 2022 tax season for the affected products listed above.

The State Controller's Office (SCO) wants to drive potential voters to get voter registration information at the Secretary of State (SOS) website by adding a question on the personal income tax returns. RE: New 3893 Scannable Voucher

Hello CTP's,

**Elective Tax for Pass-through Entities (PTE) & Credit for Owners** – Assembly Bill 150, enacted on July 16, 2021.

For taxable years beginning on or after January 1, 2021, and before January 1, 2026, California law allows entities taxed as a partnership or an "S" corporation to elect annually to pay an elective tax rate of 9.3 percent based on its qualified net income. The election shall be made on an original, timely filed return and is irrevocable for the taxable year.

The law allows a credit against the personal income tax to a taxpayer, other than a partnership, that is a partner, shareholder, or member of a qualified entity that elects to pay the elective tax, in an amount equal to 9.3 percent of the partner's, shareholder's, or member's pro rata share or distributive share of income subject to the election made by the qualified entity. A disregarded entity and its partners or members cannot claim the credit.

When to File the 3893:

**TY 2021 FTB 3893** – Taxpayers will use the 2021 voucher to make the elective tax for tax year 2021. They can use it to pay the tax by 3/15/2022.

**TY 2022 FTB 3893** - Will be available in January of 2022. Taxpayers will use the two vouchers where the first voucher is used to make the 1<sup>st</sup> payment due on 06/15/2022. They will use the 2<sup>nd</sup> voucher to make the second payment due by 3/15/2023.

Pay on or before the due date of the original return that the qualified PTE is required to file without regard to any extension of time for filing the return, for the taxable year in which the election is made.

Payments must be made by March 15, 2022 (calendar year) or the 15th day of the 3rd month (fiscal year) following the close of the taxable year. **Do not** use this form to pay the PTE estimated tax or for automatic extension.

Notice to tax software industry:

**New State of California Franchise Tax Board automated clearing house (ACH) company entry description for Golden State Stimulus II Payments**

Please be advised that the State of California Franchise Tax Board will be processing Golden State Stimulus II (GSS II) payments, authorized by Section 8150.2 of the Welfare and Institutions Code, as added by Senate Bill 139 (Stats. 2021, Ch. 71), using a new company entry description for ACH payments. GSS II will use the company discretionary data field description "XX FTB GSSTIMULUS II", as described below. The ACH transaction amount will be up to \$1,100.

**Effective immediately, financial institutions should be prepared to begin receiving GSS II payments with the new company entry descriptions.** This notice is being provided to allow financial institutions to make any processing or system preparations necessary to receive these payments.

**Note GSS II payments are in addition to Golden State Stimulus Payments (GSSP) announced March 24, 2021.**

In accordance with the National Association of Automated Clearing House Association ("NACHA") operating rules, State of California Franchise Tax Board payments will be issued with the following descriptors:

*The "XX" indicator in positions 21-22 of the "Company Discretionary Data" field identifies GSS II payments as exempt from all garnishments **except a garnishment order in connection with an action for, or a judgment awarding, child support, spousal support, family support, or a criminal restitution payable to victims.** The following table maps certain field values found in the ACH Company/Batch Header ("5") record of GSS II payments processed by the State Controller's Office.*

In an effort to provide information regarding this issue to our CTP vendors quickly, we are issuing this CTP broadcast prior to our official form revision.

FTB is in the process of revising the 2020 Schedule CA (540 & 540NR) instructions to incorporate the necessary adjustment for the federal unemployment compensation exclusion. We will be adding instructions to Schedule CA (540), Part I, Section B, line 8 and Schedule CA (540NR), Part II, Section B, line 8 as follows:

- If you excluded unemployment compensation on federal Schedule 1 (Form 1040), line 8, enter that amount as a positive number on line 8f, column C and write "UCE" on line 8f.

Note: For California purposes the full amount of unemployment compensation is already excluded above on line 7, column B. The adjustment on Sch. CA, line 8f, column C (Additions) is needed to avoid double exclusion of unemployment compensation from California income.

### **State Postpones Tax Deadlines until July 15 Due to the COVID-19 Pandemic**

**Sacramento** — The Franchise Tax Board (FTB) today announced updated special tax relief for all California taxpayers due to the COVID-19 pandemic.

FTB is postponing until July 15 the filing and payment deadlines for all individuals and business entities for:

- 2019 tax returns
- 2019 tax return payments
- 2020 1<sup>st</sup> and 2<sup>nd</sup> quarter estimate payments
- 2020 LLC taxes and fees
- 2020 Non-wage withholding payments

“The COVID-19 pandemic is disrupting life for people and businesses statewide,” said State Controller Betty T. Yee, who serves as chair of FTB. “We are further extending tax filing deadlines for all Californians to July 15. Hopefully, this small measure of relief will help allow people to focus on their health and safety during these challenging times.”

To give taxpayers a deadline consistent with that of the Internal Revenue Service (IRS) without the federal dollar limitations, FTB is following the federal relief described in [Notice 2020-17](#). Since California conforms to the underlying code sections that grant tax postponements for emergencies, FTB is extending the relief to all California taxpayers. Taxpayers do not need to claim any special treatment or call FTB to qualify for this relief.

In line with [Governor Newsom’s March 12 Executive Order](#), FTB previously extended the due dates for filing and payment last week for affected taxpayers until June 15, with the qualification that the deadlines may be extended further if the IRS grants a longer relief period, as it did yesterday. This announcement supersedes last week’s announcement.

If possible, taxpayers should continue to file tax returns on time to get their refunds timely, including claiming the Earned Income Tax Credit and Young Child Tax Credit. RE: Relief from Addition to Tax for Underpayment of Estimated Income Tax by Individual Farmers and Fishermen

On February 28, 2019, the Internal Revenue Service (IRS) issued Notice 2019-17 providing that the failure to make an estimated tax payment for the 2018 tax year is waived for any qualifying farmer or fisherman who files his or her 2018 income tax return and pays in full any tax due by April 15, 2019. California will provide a similar relief process.

### **Have not yet filed your return?**

To request a waiver of the estimated tax penalty, farmers and fishermen who have not yet filed their returns, need to complete form FTB 5805F, Underpayment of Estimated Tax by Farmers and Fishermen. Check the box on form FTB 5805F, Part II, line 16, stating the reason for the waiver request is "IRS Notice 2019-17" and attach the form FTB 5805F to their tax return. The form FTB 5805F provides detailed instructions on how to complete line 16.

**Important:** In order to process the return correctly, you **must** check the applicable box on Form 540, line 113; Long Form 540NR, line 123; or Form 541, line 44.

### **Already filed your return?**

To request a waiver of the estimated tax penalty if the return was filed and included the penalty, complete form FTB 5805F, Part II, line 16, stating the reason for the waiver request is "IRS Notice 2019-17." We have provided guidance for our CA tax products, as indicated on the Tax Form Changes Webpage.

On 3/13/2018, IRS provided instructions on how to report IRC 965 income on 2017 federal tax returns. IRS did not revise their 2017 forms. Instead, IRS created a webpage with a new IRC 965 Transition Tax Statement, instructions, and FAQs. IRC 965 Transition Tax Statement is not a standard IRS form but instead a supplemental statement. The IRS instructions for IRC 965 list reporting requirements by entity type. For additional information, IRS posted federal Pub. 5292, How to Calculate Section 965 Amounts and Elections Available to Taxpayers.

FTB will follow a similar format as the IRS by providing IRC 965 reporting requirements on FTB's website. The instructions for reporting on California tax returns will list IRC 965 adjustments required by entity type. We will not revise the 2017 California forms.

Once on the Tax Form Changes for 2017 webpage, click on the IRC Section 965 Reporting link to view the details.

**Problem:** For tax year 2017, the Franchise Tax Board is receiving the Schedule X with W-2's or other forms where the Form 540 amended return is not attached.

Without inclusion of the amended PIT return, we must contact the taxpayer for the amended return before processing can be completed.

The following are the procedures that should be followed to amend your PIT tax return:

**2017 and after:** Complete Form 540, 540NR Long, 540NR Short, or 540 2EZ and check the box indicating it is an amended tax return. Attach all revised forms, schedules and documents supporting each change, such as corrected form(s) W-2 or 1099, schedule(s) K-1, escrow statements and the Schedule X, California Explanation of Amended Return Changes.

**2016 and prior:** Use Form 540X to amend your return. Attach a revised California tax return, including all revised forms and schedules. For example, the revised Schedule CA (540 or 540NR). Write **"AMENDED, DO NO PROCESS – ATTACHMENT TO FORM 540X"** in red ink at the top of the first page of the revised California tax return.

Every season Franchise Tax Board receives a large amount of paper tax returns (mostly personal income tax) that are duplex printed; meaning the forms are printed on both sides of the paper. When we receive these substitute forms from vendors, often an information page is printed on the back of page one of the tax return. Our data capture system requires that all pages of a parent tax return be in sequential order in order to be processed quickly and efficiently. When we receive a tax return that is duplex printed, it slows down the processing of that return due to additional processes that are utilized. We are reaching out to request your assistance with educating taxpayers and tax practitioners about this issue. FTB has created verbiage that we are asking vendors to put in within their software to help mitigate this challenge.

To avoid delays in the processing of tax returns, the Franchise Tax Board requests that all mailed tax returns are printed single sided only. Duplex printed tax returns can increase the amount of time to process the return.

To effectively safeguard confidential information, the California Franchise Tax Board continually evaluates and enhances the security of protocols and cipher suites used by our Secure Web Internet File Transfer (SWIFT) Service. As a result, on March 22, 2016, we will install Service Pack 6 which updates the cipher suites composed of weak key generation algorithms (Diffie-Hellman) on the SWIFT production servers.

To ensure your file transfers are not delayed we are opening our testing environment from February 16 – March 11, 2016. We strongly recommend that you participate in the testing by using your current method of transferring files to verify that you are able to connect with the changes that will be made to our production environment. Included below is important information and testing instructions needed in order to complete your testing by **COB March 11, 2016**.

Only test data should be transferred. In order to monitor and document testing activities we request that you use the naming convention and file extension that is provided in the testing instructions below.

**Step 1:** Login to <https://swifttest.ftb.ca.gov> with the following username and password:

**Step 2:** Select the **ToFTB** folder.
