The Delaware General Assembly passed legislation on January 27, 2022 that excludes unemployment compensation from taxable income in Delaware for tax year 2021. The Division of Revenue will be posting a Technical Information Memorandum that will provide direction about this exclusion. However, in order to allow a programming update as soon as possible, please be advised that any unemployment compensation that is included in federal adjusted gross income for a Delaware resident may be excluded by including that amount on line 7 of form PIT-RES. To the extent that an individual filing a non-resident Delaware return received unemployment compensation that was included in federal adjusted gross income, this amount should be included on line 25, column A, of form PIT-NON. If the unemployment compensation was sourced to Delaware, it should also be included on line 25, column B, of form PIT-NON. If you have additional questions, please email

Changes to PIT 2d barcode for Tax Year 2021V1.0

In preparation for our new integrated Revenue Accounting System (iRAS) handling individual income tax returns, the Delaware Division of Revenue has made many changes to our 2021 tax forms and 2d barcode specifications. Due to the extensive changes, we are not listing every change since the last version in this log. We will return to our normal format in future releases.

For both the resident and non-resident 2d barcode data fields, field 5 Specification Version must be set to 2021v1.0. Please be sure to include the specification version in all 2d barcode data.

Correction for Tax Year 2020 Individual Income Tax Returns

Our prior notification that the volunteer firefighter credit was increased to \$500 was in error. The legislation authorized the increase in the credit for tax years starting on or after January 1, 2021. As a result, the correct
