Important Notice regarding MeF processing for all Tax Types – Sep 15, 2022

The DE Division of Revenue is undergoing an implementation to a new processing system. To this end, we will be pausing the acknowledgment

and download process for MeF from September 21, 2022 until October 12, 2022. You may continue to file, but we will not process returns & payments or send acknowledgments until October 12, 2022.

Update for Tax Year 2021 Individual Income Tax Returns – July 27, 2022

In preparation for start-up of the new integrated Revenue Accounting System (iRAS) handling individual income tax returns, the Delaware Division of Revenue will start enforcing the following business rules starting October 2022:

1. The SoftwareID element in the state submission's return header (ReturnState/ReturnHeaderState/SoftwareId) must match the SoftwareID value from the LOI of a Delaware approved vendor. Production submissions will be rejected if they do not include the SoftwareID listed on the approved vendor's LOI and used in their acceptance testing submission data.
2. A valid value for the stateSchemaVersion attribute (ReturnState/@stateSchemaVersion) must be included in all state submission data. Below are the schema versions currently supported in production.

Tax Year	State Schema Version	Tax Type

3. The StateSubmissionManifest data must include the correct values for submission type (StateSubmissionManifest/StateSubmissionTyp) for each supported tax year. Please note that the value for the manifest submission type element must match the values listed exactly.

Update for Tax Year 2021 Individual Income Tax Returns

The Delaware General Assembly passed legislation on January 27, 2022 that excludes unemployment compensation from taxable income in Delaware for tax year 2021. The Division of Revenue will be posting a Technical Information Memorandum that will provide direction about this exclusion. However, in order to allow a programming update as soon as possible, please be advised that any unemployment compensation that is included in federal adjusted gross income for a Delaware resident may be excluded by including that amount on line 7 of form PIT-RES. To the extent that an individual filing a non-resident Delaware return received unemployment compensation that was included in federal adjusted gross income, this amount should be included on line 25, column A, of form PIT-NON. If the unemployment compensation was sourced to Delaware, it should also be included on line 25, column B, of form PIT-NON. Update for Tax Year 2020 Individual Income Tax Returns

Due to the passage of the American Rescue Plan (ARP), an update has been issued to the guidance to taxpayers about how to exclude unemployment benefits from income on their 2020 Delaware income tax return.

Correction for Tax Year 2020 Individual Income Tax Returns

Our prior notification that the volunteer firefighter credit was increased to \$500 was in error. The legislation authorized the increase in the credit for tax years starting on or after January 1, 2021. As a result, the correct firefighter credit for Delaware for the 2020 tax year is \$400. Update for Tax Year 2020 Individual Income Tax Returns

The Delaware General Assembly passed legislation on January 28, 2021 that excludes unemployment compensation from taxable income in Delaware for tax year 2020. The Division of Revenue will be posting a Technical Information Memorandum that will provide direction about this exclusion. However, in order to allow a programming update as soon as possible, please be advised that any unemployment compensation that is included in federal adjusted gross income for a Delaware resident may be excluded by including that amount on line 36 of form 200-01. To the extent that an individual filing a non-resident Delaware return received unemployment compensation that was included in federal adjusted gross income, this amount should be included on line 25, column 1, of form 200-02. If the unemployment compensation was sourced to Delaware, it should also be included on line 25, column 2, of form 200-02.
