

# Instructions for Idaho Form 51

*(Return the bottom portion only if you're making a payment.)*

**A. GENERAL INFORMATION**

If you can't file your Idaho tax return by April 15, 2019, you'll be allowed an automatic six-month extension if you've paid at least:

- 100% of the income tax reported on your 2017 return (if a return was filed), or
- 80% of the estimated tax due on your 2018 return.

If you qualify for the automatic extension, file your extended tax return by October 15, 2019.

An extension of time to file your return isn't an extension of time to pay your tax.

If you owe \$50 or less, a payment isn't required to have a valid extension. However, we'll charge you interest.

Complete the tax payment worksheet below to calculate the payment due.

Payments must be postmarked or made online by April 15, 2019.

You can use Form 51 to make payments of Qualified Investment Exemption (QIE) recapture when you don't file your income tax return by the due date. Write "Payment of QIE Recapture" at the bottom of the form and return it with a check.

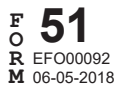
