

Enter the business name, address, EIN, phone number and contact persons name in the spaces provided.

If business name or address information has changed since last year, be sure to fill the "Name or Address Change" field with two "XX".

If you are paying for an amended return, fill the appropriate field with two "XX"

If you are filing an extension of time to file your return, fill the appropriate field with two "XX". Note that an extension of time is an extension to file, NOT an extension to pay.

Make your check or money order payable to "Kansas Corporate Income Tax" for the full amount of your tax due. Write the last 4 digits of your EIN on your check or money order, and ensure it contains a valid telephone number.

DO NOT send cash. If payment is not made on or before **April 15, 2025**, the tax due is subject to penalty and interest.

Do not attach the payment voucher or payment to your return or to each other. **Place them loosely** in the envelope

with your return. If you have already mailed your return, or you filed electronically and didn't pay electronically, mail your payment and the voucher to:

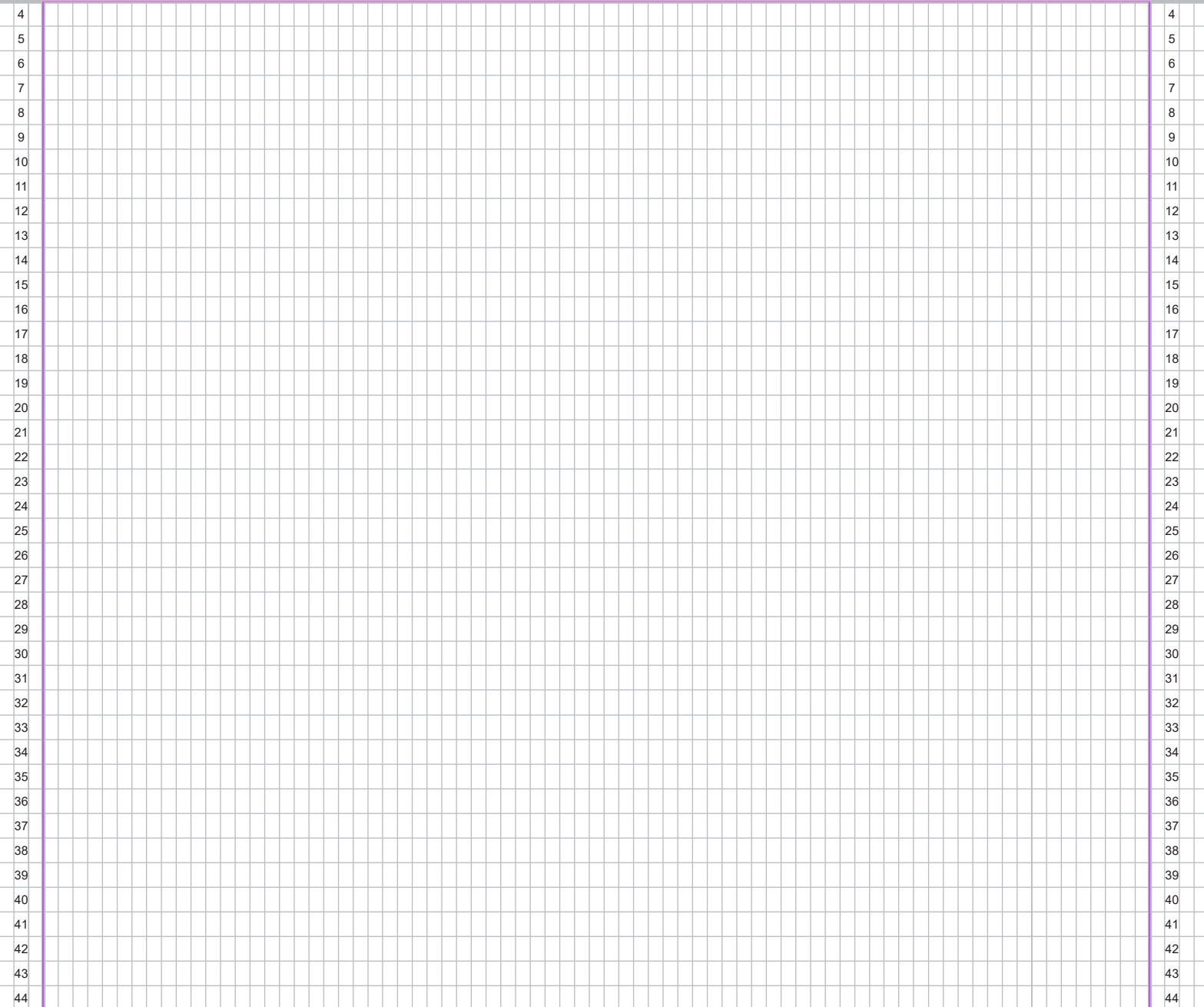
