Purpose of Form

Form 8948 (K–C)—Request for Waiver of Electronic Filing Requirement can be used by taxpayers if they have a valid reason why they are not able to file a Kentucky corporation or pass-through entity income tax return electronically. This form is only applicable for Forms 720, 720U, 725, PTE, 740NP-WH, and 740-PTET and must be submitted to the Department of Revenue for approval before filing on paper. A copy of the approved form signed by DOR must be attached to the paper-filed return. **KRS 131.250**

How to Submit

Completed Form 8948 (K–C) must be submitted by the taxpayer, tax preparer, or responsible party via e-mail to *KRC.WEBResponseCorporationTax@ky.gov* or *DORWEBRESPONSEPASSTHROUGHENTITY@ky.gov* for approval **before** filing on paper.

Determination

The Department of Revenue will review your request for approval or denial and provide a response to the contact provided on the request.

A copy of the approved form signed by DOR must be attached to the paper-filed return.

If denied, the company should file electronically.
