



**Electric and Hybrid
Vehicle Road Usage Fee**

Pursuant to La. R.S. 32:461, individuals and businesses that own or lease an electric or hybrid vehicle that is required to be registered in Louisiana must pay a road usage fee to Louisiana Department of Revenue ("LDR") annually. The fee is \$110 for electric vehicles and \$60 for hybrid vehicles owned/leased per calendar year. Vehicles owned or leased for less than one year are subject to a prorated fee as provided in LAC 61:I.5501.

- Report the fee on the appropriate line of your Louisiana individual income tax return and attach Form R-19000A (Schedule A on Page 2 of this form).

All businesses, including corporations or other entity types, must pay the fee by filing this form together with Form R-19000A (Schedule A on Page 2 of this form). Taxpayers with more than two vehicles must submit additional copies of Form R-19000A (Schedule A on Page 2 of this form) to report all vehicles with their filing.

This form is due on or before the 15th day of May and becomes delinquent on the first day thereafter. If the due date falls on a weekend or legal holiday, the return is due the next business day and becomes delinquent the first day thereafter.
