Dear Free File Alliance Tax Software Developer:

The Montana Department of Revenue would like to partner with software industry members of the Free File Alliance (FFA) to obtain free preparation and filing of Montana tax returns. We request your participation in the Montana Free File program for Tax Year 2025

Montana will provide a link to your company's online Free File tax preparation software on a specific Free File site through the Montana Department of Revenue website if your company:

- 1. Offers free electronic return preparation and filing services for both the Federal and Montana tax returns to Montana taxpayers filing for Tax Year 2025 (Free Services); and
- 2. Each year successfully completes both the Internal Revenue Service (IRS) and Montana Participant Acceptance Testing (PATS) system tests.

In addition, your offer must meet the following standards:

- 1. We must receive the eligibility requirements for your Montana Free File offer no later than December 26, but preferably earlier in mid-December, to assure placement of your offer listing on our Free File web page at the opening of efiling. With your authorization, Montana will publish this information on our website as soon as it becomes available. This gives our taxpayers time to review the offers before they are ready to file their returns.
- 2. The eligibility requirements must be stated in terms that are clear and will be readily understood by the targeted taxpayers.
- 3. All eligible Montana filers must be able to receive the Free Services whether they access your product through the Montana website or via www.irs.gov.

- 4. Eligibility requirements for free Montana services must match the eligibility requirements for the IRS Free File federal services to avoid taxpayer confusion and concerns. If the eligibility requirements for your company's free federal services are changed during the filing season, as permitted no more than twice per year, you must immediately notify the Montana Department of Revenue so that your listing on the State's Free File web page can be updated accordingly.
- 5. Returns e-filed under the Montana Free File program will include the "Free File" Special Program Type in the Return Header as specified in the Montana schema (equivalent to the "Consortium Return Code," Field 0285 in the Return Header of the federal schema).
- 6. You must agree to provide Montana with the number of Montana Free File returns filed under the program with your software on an as-requested basis (not to exceed one request per month) throughout the e-file season. Montana will combine your data with the data from other Free File software developers and disclose it only as an aggregate total.

In response, the Montana Free File program will incorporate by reference the applicable terms and conditions of the federal IRS Free File program as memorialized in the Free File Policy Agreement of October 30, 2002, between the Internal Revenue Service and the Free File Alliance LLC, as amended, and the currently applicable IRS/FFA Memoranda of Understanding applicable through filing season 2029. The applicable terms and conditions include, for example, any service levels, required disclosures and testing, privacy, security, and the other mutual covenants contained in those documents.

Montana Department of Revenue will work with the participating and qualified Free File software developers to develop the content that will appear on the State Web page. However, Montana Department of Revenue has final approval of that content. Montana Department of Revenue will not endorse or recommend specific products or businesses but will promote the availability of the Free Services.

Montana retains the right to accept electronic returns and to provide links from its or other Montana websites to businesses offering electronic return preparation and/or filing services to Montana taxpayers, whether or not the business is a participant in the Federal Free File. However, the department will only solicit and list Federal Free File

program participating companies, and the department cannot offer a state sponsored software program in filing season 2026.

[Please note: The 'pilot' program that FFA conducted in 2025, which permitted a state that has a competing state sponsored software product to receive Free File Services, is NOT being offered.]

Either party may terminate this agreement upon written notice if the other party is in material breach and such breach remains uncorrected for thirty (30) days following receipt of written notice. A "force majeure event" (e.g., acts of God, Internet failures, or other acts beyond one's reasonable control) shall not be considered a material breach. Additionally, either party may terminate this agreement for any reason on at least thirty (30) days advance written notice, to be effective not earlier than October 20th of the tax filing season then in effect.
