Prefer to Mail Your Payment?

- Make the check or money order payable in U.S. dollars to the NC Department of Revenue. Note: The Department will not accept a check, money order, or cashier's check unless it is drawn on a U.S. (domestic) bank and the funds are payable in U.S. dollars.
- Enter the last four digits of the corporation's FEIN, Tax Year, and "CD-429 Corp" on the memo line of the check or money order.
- Make sure the check or money order is signed.
- Make sure the correct name, address, and contact phone number appear on the check or money order.
- Cut across the dotted line and send the completed voucher and check or money order to N.C. Department of Revenue, P.O. Box 25000, Raleigh, N.C. 27640-0650.

Important Reminders

- Do not print double sided.
- Do not mail the voucher if you submitted an electronic payment.
- Do not staple, tape, paper clip or otherwise attach the check to the voucher.
- Do not fold the voucher or check.
- Do not use a photocopy of the voucher.
- Do not use another corporation's voucher.
- Do not send cash.
- Do not make any modifications to the voucher.
- Make sure an authorized signature appears on the check or money order.
- Make sure the correct name, address, contact phone number, and tax year appear on the voucher and the check or money order.
- Make sure the corporation's full FEIN is printed on the voucher and the last four digits of the FEIN appear on the check or money order.
