Did you know you can submit your payment online for free? If you pay online, you do not have to print and mail the youcher.

- Bank drafts (free), MasterCard or Visa (\$2 convenience fee for every \$100 paid)
- Your payment will be processed efficiently and you will receive a payment confirmation

Prefer to Mail Your Payment?

- Make your check or money order payable in U.S. dollars to the NC Department
 of Revenue. Note: The Department will not accept a check, money order, or
 cashier's check unless it is drawn on a U.S. (domestic) bank and the funds are
 payable in U.S. dollars.
- 2. Make sure the courtesy box and legal line on your check match.
- Enter the last four digits of your SSN, Tax Year, and "D-400" on the memo line of your check or money order. If you are filing a joint return, enter the last four digits of the first SSN on your return.
- 4. Make sure your check or money order is signed.
- 5. Make sure your name, address, and daytime phone number appear on your check or money order.
- 6. Cut across the dotted line and send the completed voucher and your check or money order to the "Mail to" address on the voucher.

Important Reminders

- Do not print double sided.
- Do not mail the voucher if you submitted an electronic payment.
- **Do not** staple, tape, paper clip or otherwise attach your check to the voucher.
- Do not fold the voucher or check.
- **Do not** use a photocopy of the voucher.
- Do not use another person's voucher.
- Do not send cash.
- Do not make any modifications to the voucher.
- Make sure your signature appears on your check or money order.
- Make sure the correct name, address, daytime phone number, and tax year appear on the voucher and your check or money order.
- **Make sure** your full SSN is printed on the voucher and the last four digits of your SSN appear on the check or money order.
