Purpose

If you are applying for an extension of time to file your 2026 North Dakota individual income tax return, you may make an extension payment to prepay the tax that you expect to owe to avoid paying extension interest.

If you make an extension payment, you must file Form ND-1 and claim the payment on page 2, line 27.

The payment must be made no later than April 15, 2027, to avoid extension interest.

Important. Do not use this voucher if:

- Choose to make the payment electronically—see “How to make payment” for your payment options.
- File your return on or before April 15, 2027.
- Pay your balance due after April 15, 2027.
- Are not submitting a payment with the voucher.

If you file your return after April 15, 2027, any tax paid with the return is subject to extension interest.

How to Make a Payment

Electronic payment options

Instead of paying by check or money order with this payment voucher, the payment may be made electronically with an electronic check, a debit or credit card, or an Automated Clearing House (ACH) credit transaction.

To pay electronically, or for more information, go to www.tax.nd.gov and select “Make A Payment.”

Check or Money Order

If paying by check or money order, make it payable to “ND State Tax Commissioner” and write last four digits of Social Security number(s) and “2026 ND-1EXT” on it. Complete the payment voucher below, detach it from this page, and mail it with the payment to:
