You may submit a payment with the payment voucher below or pay estimated fiduciary income taxes online at no charge by electronic check. You can pay online through Taxpayer Access Point (TAP) at https://tap.state.nm.us. Under Payments, click10 Make a Payment, then click Business. From the Account Type drop-down, select Fiduciary Income Tax. The electronic check authorizes the Department to debit your checking account in the amount and on the date you specify. You may also 12 use a credit card for your online payment. A convenience fee is applied for using a credit card. The State of New Mexico 13 uses this fee, calculated on the transaction amount, to pay charges from the credit card companies. 

SUBMIT ONLY A HIGH-QUALITY PRINTED, ORIGINAL FORM AND FOLLOW THESE INSTRUCTIONS. With the 16 high-speed scanners the Department uses when processing payment vouchers, a quality form helps ensure accuracy. Do17 not use a photocopy of the voucher. Because the scanners can read only one page size to process vouchers, it is important<sub>18</sub> to **cut on the dotted line only**. When printing the voucher from the Department website or a software product, prevent<sub>19</sub> resizing by setting the printer's page scaling function to **None**. If your payment youcher has a scanline (a very long row of<sub>20</sub> numbers) within the bottom 1 and 1/2-inch of the voucher, do not write in the area around the scanline.
