Example: Mr. and Mrs. Brown are filing a joint return. Their New Mexico Taxable Income on line 17 of the Form PIT-1 is \$25,325. First they find the \$25,300-\$25,400 income line. Next they find the column for **Married Filing Jointly** and read down the column. The amount shown where the income line and filing status column meet is \$679. This is the tax amount they must write on line 18 of the Form PIT-1.
