If the application is properly completed and submitted with the correct filing fee, the Secretary of State will file the application and return a conformed copy stamped with the effective date of filing. Each Registered Limited Liability Limited Partnership must file an annual report with the Secretary of State by the fifteenth day of the fourth month following the close of the Registered Limited Liability Limited Partnership's fiscal year.

The fee for the annual report is \$200.
