### State of Arkansas Scan Line Specification for Individual and Corporation Extension Vouchers

Effective immediately, the scan line on all extension vouchers <u>must</u> use the correct font and font size. The scan line <u>must</u> be in the correct location. If the font, font size or placement of scan line is incorrect, extension vouchers will not be approved for reproduction.

Font: IdAutomationOCRa Font Size: 9

There must be a half (1/2) inch clearance around the scanline.

### Location:

Bottom of page to bottom of scan line – 16 mm or 0.63 inch Right edge of paper to right edge of scan line – 25 mm or 1 inch Left edge of paper to left edge of scan line – 53 mm or 2.08661 inches Scan line is approximately 136-137 mm long. RIGHT justified

### **Grid Location:**

On a 6 line per inch/10 character per inch grid with the voucher forced to the bottom of the page, the scan line falls on the line between 62 and 63 or at the bottom of line 62, Space 75, right justified

### **OCR Scan Line Definitions:**


- 1. Specifically this designates the **Tax Type**. (3 characters in length)
  - a. "IIT" for Individual Income Tax
  - b. "CIT" for Corporate or Sub S Corporation Tax
  - c. "FIT" for Fiduciary Income Tax
  - d. "ICT" for Composite Filing Income Tax
- 2. **ID Type** EIN or SSN. (3 characters in length)

### Tax Type Corresponding ID Type

IIT	SSN
CIT	EIN
FIT	EIN
ICT	EIN

- 3. EIN or SSN (must match ID Type in item #2) Two leading zeros + the SSN/EIN

   Example: 00123456789 (11 characters in length)
- 4. **Period Ending** Example: 12312019 (8 characters in length) This is always the last day of the ending month of the tax year.
- 5. **Payment Type** (6 characters in length) a. EXTPYM for Extension Tax Payment.
- 6. Padded with 23 Zeros
