2018 IA 8453-S Instructions

The IA 8453-S must be completed and then signed by the president or other duly authorized officer.

In lieu of an in-person handwritten signature otherwise required on Form IA 8453-S, the Iowa Department of Revenue allows a paid preparer, at the discretion of the S corporation, to collect the officer's electronic signature remotely by a process using identity verification and audit trail in the manner that the IRS allows for Form 8879-S.

Enter the name and Federal Employer Identification Number (FEIN) of the S corporation at the top of this form.

Part I – Return Information

Complete using amounts from the Iowa income tax return for S corporations.

Part II – Declaration of Officer

- 1. Verify the accuracy of the tax return.
- 2. Read, sign and date this form.
- 3. Return the completed form to the ERO or paid preparer if using one.
- 4. Retain copies of the signed IA 8453-S and all attachments for three years from the due date or filing date, whichever is later.
