Pay your income tax electronically at www.maine.gov/revenue and eliminate the necessity of filing Form 1040ME-PV (individual income tax payment voucher).

Maine EZ Pay is an online application that allows Maine taxpayers to make payments online, quickly and easily. To avoid having to make payments earlier than necessary, payments may be scheduled in advance and will automatically be withdrawn on the payment date the taxpayer selects. 

12 Taxpayers must pre-register online with personal and bank account information, and payments will be withdrawn from the checking or 13savings account that is set up in the registration. For more information, see www.maine.gov/revenue (click on Electronic Services).

To mail your payment, follow the instructions below.
