**Purpose of this form**. Use this 2022 FID-EXT payment voucher to make an extension payment towards a 2022 fiduciary income tax <sup>7</sup>/<sub>1</sub> liability. An extension payment requires a federal automatic extension or a New Mexico extension; a payment towards a potential tax <sup>8</sup>/<sub>1</sub> liability with FID-EXT avoids accrual of interest, if paid timely. By obtaining an extension of time to file your return, penalty for failure to file and pay is waived through the extension period, provided you file the return and pay the tax shown on the return by the ex-<sup>9</sup>/<sub>1</sub> tended due date. Interest accrues even if you obtain an extension of time to file and pay the return. Interest is assessed daily at the <sup>10</sup>/<sub>1</sub> quarterly rate established by the U.S. Internal Revenue Code on the amount of tax due. The Department posts annual and daily interest <sup>11</sup>/<sub>1</sub> rates for each quarter at <u>www.tax.newmexico.gov</u>. In the black navigation bar at the top, click **INDIVIDUALS**. Under **FILE YOUR TAXES**, <sup>12</sup>/<sub>13</sub>

If you expect to owe more tax when you file your 2022 return and you obtained an extension of time to file, make a payment using the <sup>14</sup> 2022 FID-EXT payment voucher to avoid the accrual of interest on the principal tax due. Submit the payment voucher at the bottom with <sup>15</sup> your check or money order.

## About the Application for Extension of Time to File.

 Federal automatic extension filed. New Mexico recognizes and accepts an Internal Revenue Service (IRS) automatic extension 19 of time to file. If you obtain the federal automatic extension by filing Form 7004, *Application for Automatic Extension of Time to File* 20 *Certain Business Income Tax, Information, and Other Returns* for tax year 2022, you have the federal automatic extension period 21 allowed by the IRS to file your New Mexico return. You do not need to file Form RPD-41096, *Application for Extension of Time to File*.

To request approval, you must submit Form RPD-41096, *Application for Extension of Time to File*, on or before the due date of the return or the extended due date of the return. You may submit RPD-41096 at the same time you submit your extension payment.

You may submit your payment with the payment voucher below or pay online at no charge by electronic check. You can pay online through 29 Taxpayer Access Point (TAP) at https://tap.state.nm.us. Under GENERAL TASKS, click Make a Payment and then Business. From the 30 Account Type drop-down, select Fiduciary Income Tax. The electronic check authorizes the Department to debit your checking account in the amount and on the date you specify. You may also use a credit card for your online payment. A convenience fee is applied for using a credit card. The State of New Mexico uses this fee, calculated on the transaction amount, to pay charges from the credit card companies. To file a New Mexico application for extension of time to file and pay, you must submit Form RPD-41096.

**NOTE:** When you provide a check as payment, you authorize us to use information from your check to make a one-time electronic fund <sup>35</sup> transfer from your account. When we use information from your check to make an electronic fund transfer, funds may be withdrawn from <sup>36</sup> your account the same day you make your payment. <sup>37</sup>
