5	Generally, your Oklahoma income tax is due April 15th. However:
6	• If you electronically file your return and pay electronically, your due date is extended until April 20th. Log on to www.
7	tax.ok.gov and visit the "Online Services" link to make a payment electronically.
9	• If the Internal Revenue Code (IRC) of the IRS provides for a later due date, your payment may be made by the later
2 0	due date and will be considered timely.
1	If the due date falls on a weekend or legal holiday when OTC offices are closed, your payment is due the next
2	business day.
3	How To Prepare Your Payment
4	Remit only one check or money order per voucher.
5 6	Make your check or money order payable to the "Oklahoma Tax Commission". Do not send cash.
7	Make sure your name and address appear on your check or money order.
8	How To Send In Your 2018 Tax Payment, and Form 511-V
9	Cut Form 511-V along the dotted line and submit the bottom portion of the Individual Income Tax Payment Voucher.
3 0	Do not staple or otherwise attach your payment to Form 511-V. Instead, just put them loose in the envelope.
2	• Do not include a copy of your income tax return. To use this form, your income tax return (either paper or
3	electronic) should already be filed with the Oklahoma Tax Commission.
