PART I. FLAT EXCLUSION

1. Enter smaller of Line 15 or 16 from federal Form 1040, Schedule D **1.** 123456789 .00
 2. Enter amount from:
 - 2a. Federal Form 1040, Schedule D, Line 18. **2a.** 123456789 .00
 - 2b. Federal Form 1040, Schedule D, Line 19. **2b.** 123456789 .00
 3. Add Lines 2a and 2b. **3.** 123456789 .00
 4. Subtract Line 3 from Line 1. **4.** 123456789 .00

5. Enter amount from:

PART II. PERCENTAGE EXCLUSION

10. Enter the amount from Part I, Line 410. 123456789 .00

11. Enter amount of adjusted net capital gain from the sale of assets held for three years or less11. 123456789 .00

PART III. CAPITAL GAIN EXCLUSION

19. Enter the *greater of* Line 9 or Line 1819. 123456789 .00

20. Multiply 123456789 .00 x 40% and enter result here20. 123456789 .00
Federal Taxable Income

21. Enter the *smaller of* Line 19 or Line 20. This is your capital gain exclusion. Enter on Schedule IN-112, Part I, Line 721. 123456789 .00
